#### Introduction

The requirements of ISO 19011 series of Guidelines for Quality and /or Environmental Management Systems Auditing explicitly specify requirements for appropriately qualified personnel to perform the audit task.

An efficient internal auditing procedure is crucial to good Quality Management System (QMS). It helps to locate system faults or oversights and allow corrective action to be taken to eliminate the root cause of the nonconformance. An effective and efficient internal audit will provide management with an accurate reporting on the overall QMS performance at a minimum cost.

This course is designed for internal quality auditors to carry out an effective audit on the company's overall quality system to comply with ISO 9001

It provides the audit framework, which covers auditing skills, objective information and evidence gathering, writing of audit notes and audit report.
